## Eligibility

The visiting student **must be at the senior/final level** of medical school at the time of the proposed elective.

The University of Nebraska Medical Center College of Medicine (COM) does **not** accept applications from students attending:

- · foreign medical schools,
- non-LCME accredited M.D. institutions,
- non-COCA accredited D.O. institutions.

### **Rotations**

Elective rotations are four (4) weeks in length and are offered each month of the academic year. The visiting student will be expected to adhere to the COM rotations schedule (https://catalog.unmc.edu/medicine/ academic-calendar-2025-2026/#classof2026text) and be able to attend all four (4) weeks of the offered rotation. **Only one (1) rotation can be accepted** per visiting student.

The COM does not offer two (2) week elective rotations.

## **Application**

Only **complete applications** submitted through the VSLO application service will be reviewed for consideration.

A complete application consists of the following:

- 1. CV Uploaded
- 2. Headshot Uploaded
- 3. Home Institution Transcript Uploaded
- 4. Immunizations Uploaded and verified by student health representation or physician
- 5. Transcript Uploaded

- 6. State and Federal Background Check uploaded; required background check searches:
  - a. Social Security Number Verification
  - b. Nationwide Federal Criminal
  - c. US Nationwide Criminal
  - d. Sex Offender Registry
  - e. Statewide Criminal
  - f. Adult and Child Abuse Registry
  - g. Office of Inspector General Sanctions
- 7. Verification of Student Credentials (Completed by your Home institution)
  - a. Student is in good standing
  - b. Current HIPAA Training
  - c. Current OSHA Training
  - d. Current BLS
  - e. Mask Fit test completed
  - f. Medical Liability in the amounts of \$3M aggregate and \$1M Per Instance
  - g. Passed USMLE Step 1 / COMLEX Score
  - h. Completion of Core Clerkships before the start of any requested elective
    - i. Family Medicine
    - ii. Internal Medicine
    - iii. Obstetrics and Gynecology
    - iv. Pediatrics
    - v. Psychiatry
    - vi. Surgery
